The Medical Council of India vide letter No.MCI-34(MC)/2016/140022 dated 16.09.2017 had discharged 17 students of Sakshi Medical College & Research Center, Guna who were admitted under NRI category.

Following students approached Admission and Fee Regulatory Committee with written applications requesting refund of fee from Sakshi Medical College due to cancellation of their admissions:-

One of the students Mr.Jayant Soni also filed a Writ Petition before the Hon'ble High Court, Gwalior Bench. The Hon'ble High Court in W.P.No.1742/2020 directed the applicant to approach AFRC regarding refund of fees in accordance with law.

In compliance of the above direction of Hon'ble High Court an opportunity of hearing was granted to the institution on 05.11.2020 but no representative turned up and on the request another opportunity was given for hearing on 22.12.2020. During hearing the representative of the institution requested for two months time for refund of fee to the students. Accordingly the institution was asked to furnish written assurance regarding refund of the fee and time limit required for this purpose.

However, instead of submitting written assurance regarding refund of fees to the students vide letter No.MSESPEPS/6015/31/12/2020 dated 31.12.2020 you requested to grant time till decision in the various cases filed by the students before the Hon'ble High Court, Gwalior and thus back tracked from the assurance given during hearing on 22.12.2020.

As per decision taken by AFRC in the meeting held on 22.01.2021 you are directed to refund the fee collected from Mr.Jayant Soni and other students whose admissions were cancelled by Medical Council of India, within 30 days from the date of issue of this order and report compliance to AFRC Secretariat.
