ORDER

The matter relates to cancellation of admission of 107 students admitted in MBBS/BDS Courses in NRI quota, in the year 2017, by the DME by its Order dated 28.11.2017.

Several Petitions were filed in the Hon'ble High Court by the aggrieved students.

The Hon'ble High Court in the bunch of Writ Petitions including WP No.14826/2017 (**Shivani Singh Vs.The State of M.P. and Others**) filed by students whose admission was so cancelled, directed this Committee to:

*"Consider the validity of the admissions granted by the private colleges under the NRI quota seats on the same basis as has rightly been done by the State itself in its report, that is, in accordance with the guidelines laid down by this court in the case of **Anshul Tomar** (supra) which are based on the directions issued by the Supreme Court in the case of **P.A.Inamdar** (supra) and **Ruchin Bharat** (supra)".*

It was further observed therein that –

*"We think it necessary to clarify that this court has not expressed any opinion in respect of the validity or otherwise of the admissions granted to individual petitioners or to the fact as to whether they fall within the category of NRI as prescribed in Regulation 6(2) of the Regulations of 2017 and the broader criteria prescribed and approved in the case of **Anshul Tomar** (supra), and therefore, the Admission and Fee Regulatory Committee would be at liberty to examine each case individually in respect of the facts of each case and take an independent decision in that regard".*

In pursuance to the above observations and directions of the Hon'ble High Court each candidate admitted in the year 2017 in MBBS/BDS course in NRI quota and whose admission was cancelled by DME, had been given opportunity of hearing as ordered by the Hon'ble High Court, and documents submitted by the students were also perused.

Committee after examining and **considering** each case individually in respect of the facts of the matter, found the status of candidates as follows :-

- (i) Total 53 Candidates shown in **Appendix-A** are found to have been sponsored by NRIs; therefore, their candidature and admission is found valid.
- (ii) Total 39 Candidates in **Appendix-B** are found to be sponsored by OCIs and therefore they are also found eligible for admission in view of Notification No.26011/2/2005-IC-II dated 11.04.2005 Issued by Govt. of India, bringing the OCIs at par with NRI for the purpose of education. Accordingly, their admission is found valid.
- (iii) Total 2 candidates in **Appendix-C** are found to have been sponsored by PIOs and therefore they are also found eligible for admission in view of Notification No.26011/01/2014-IC-I dated 09.01.2015 Issued by Govt. of India, bringing the PIOs at par with NRI & OCI for the purpose of education. Accordingly, their admission is found valid.
- (iv) Two Candidates shown in **Appendix-D** are prima-facie appear to have been sponsored by NRIs; therefore, their candidature and admission is considered provisional subjected to submission of **Documents**.
- (v) **However**, candidature of the 5 candidates shown in **Appendix-E** are not found to be in order and proper as they were not found to be covered in the criteria of NRI sponsored candidates. Candidature of the 6 candidates shown in **Appendix-F** are not found proper as they had failed to provided satisfactory documents to prove the NRI status of their Sponsor. Therefore, order of cancellation of their admissions by the DME was found to be proper and would remain undisturbed.

Summarily after after examining each case individually and in totality of the facts of the case, the final status of candidates as follows :-
