ORDER

In exercise of the power conferred by sub-section (1) of the Section 9 of **Madhya Pradesh Niji Vyavsayik Shikshan Sanstha (Pravesh Ka Viniyaman Avam Shulk Ka Nirdharan) Adhiniyam, 2007**, the Admission and Fee Regulatory Committee hereby determines the fee for Medical and Dental Institutions as follows:

a) The Institutions have been categorized under three categories for determining the duration of applicability of fee:

Category A: (i) Dental Institutions offering BDS course which have completed three years.
(ii) Medical Institutions offering MBBS course.
(iii) Dental Institution offering MDS course.

Category B: Dental Institutions offering BDS course which have not completed three years.

Category C: Institutions started in year 2007-08

b) For category - A Institutions, the determined fee structure is applicable for 2006-07 and 2007-08. The fee structure for 2008-09 and 2009-10 will be declared in due course. For category –B Institutions, the determined fee is applicable for 2006-07 and 2007-08 only. These Institutions will have to approach the Committee again for 2008-09 and onwards fee structure. For category –C Institutions, the determined fee structure is of interim nature and the final fee will be determined only after the completion of first session.

c) Fee for the aforesaid categories of Institutions is determined as under:

i) In the light of Supreme Court order in W.P. No. 380/2004 and S.L.P. (C) 14862 of 2007, determined fee for 2006-07 and 2007-08 will be chargeable from the students admitted from session 2004-05 onwards.

ii) Caution Money may be obtained only upto a maximum of 5% of the applicable tuition fee in the year of admission as mentioned hereinabove. Excess caution money, if any, obtained from students admitted during 2006-07 and 2007-08 shall either be refunded or adjusted against the receivables. Shortage, if any, is not recoverable from the students.

iii) The Institutions will not charge any other fee in whatsoever name and guise except the University fee in accordance with the University Rules.

iv) Institutions providing various ancillary facilities to students like mess, transportation, hostel and training, placement shall charge, from the actual user of such facilities, the actual cost of such facilities only on no profit no loss basis. Additional receipts on these heads, if any, shall either be adjusted in the next year or be refunded to the students. The institutions are required to maintain separate account for all such receipts and expenditure incurred.

v) Institutions are advised to maintain separate account for **Growth and Development fee** that includes additional fee collected from NRI students and the expenditure incurred therefrom. Institutions may be required to submit details of fee earned and expenditure incurred from these funds.

vi) The Committee will encourage the Institutions to obtain Accreditation from National Board of Accreditation or ISO certification.

vii) **As per directives of Supreme Court in W.P. No. 14862/2007 institutions are required to adjust excess/deficit amount of fee taken in 2006-07 in the year 2007-08 and compliance of the same should be reported to the Committee within 30 days from the issue of this order.**
